## Calculate your savings

To determine your Qualifying Rebate Level and estimated rebate, use the tables below or access our easy-to-use online rebate calculator at [www.PestPartners365.com/Calculator](http://www.PestPartners365.com/Calculator). This tool helps you develop purchase scenarios to determine your maximum savings potential specific to your business needs.

### USE OUR 2017 PROGRAM WORKSHEET

Use these tables to determine your Qualifying Rebate Level and Qualifying Period Rebate Estimate for 2017 yearlong savings.

- **Qualifying Base Rebate** = (Base Rebate \$/unit) x Purchase Quantity
- **Qualifying Base Rebate Total** = Sum of values in Qualifying Base Rebate column
- **Qualifying Period Rebate Estimate** = Qualifying Base Rebate Total (from Table 2) x Qualifying Rebate Multiplier (from Table 1)

### TABLE 1

Use the Qualifying Base Rebate Total to determine your Qualifying Rebate Level in the following table:

Qualifying Rebate Level	Qualifying Base Rebate (\$)	Qualifying Rebate Multiplier
Partner	≥ \$200	1.0
Silver	≥ \$500	1.2
Gold	≥ \$1,000	1.4
Platinum	≥ \$2,000	1.6
Diamond	≥ \$3,000	1.8

### SAMPLE CALCULATION

A Pest Management Professional (PMP) earns a Qualifying Base Rebate Total of \$1,050 during the Qualifying Period, which places his or her company at the Gold Level. To determine the Qualifying Period Rebate Estimate, he or she would use the following equation and the multiplier value from Table 1:

**Qualifying Period Rebate Estimate:** Qualifying Base Rebate Total (\$1,050) x Qualifying Rebate Level Multiplier (1.4) = Qualifying Period Rebate Estimate of \$1,470

The Qualifying Rebate Level and multiplier earned by the PMP during the Qualifying Period will be used to determine rebate savings for Qualifying Product purchases through September 30, 2017.
